Upon motion made by Kimberley Payne, seconded by Randy Cardo, and unanimously carried, it was RESOLVED, pursuant to Section 209-i.1-b of the New York General Municipal Law, that (1) whenever an active volunteer firefighter of the Quogue Fire Department provides services under General Municipal Law Section 209-i when there is no jurisdictional officer in command present, such volunteer firefighter shall, notwithstanding the absence of such jurisdictional officer in command, be entitled to coverage under the New York Volunteer Firefighters Benefit Law, (2) upon the arrival of a jurisdictional officer in command, such volunteer firefighter shall be entitled to the benefits of such Law in the manner specified in Section 209-i, and (3) this resolution and shall be effective as of June 15, 2015, the effective date of Section 209-i.1-b.
