Upon motion made by Randy Cardo, seconded by Ted Necarsulmer and unanimously carried, the Minutes of Regular Meeting held on July 22, 2016 were approved.

Upon motion made by Jeanette Obser, seconded by Ted Necarsulmer and unanimously carried, it was RESOLVED, a permit for a bake sale by the members of the AME Zion Church to be held on the Village Green on September 3, 2016 from 10 A.M until 3 P.M is approved.

Upon motion made by Kimberley Payne, seconded by Ted Necarsulmer and unanimously carried, it was RESOLVED, the renewal of the Maintenance Service Agreement with Arenz Heating & Air Conditioning for the heating and air conditioning equipment in Village Hall (2 gas boilers, 6 condensing units) at a cost of \$1,291.50 for the term of 9/1/16 through 2/29/17 is approved.

Upon motion made by Ted Necarsulmer, seconded by Kimberley Payne and unanimously carried, it was RESOLVED, Cardmember Service purchase order 14723 is increased in the amount of \$152 to cover an additional night's accommodation.
