The Mayor opened the Public Hearing with respect to the following Local Law No. of 2017, A Local Law Amending Chapter 82 of the Village Code with respect to dogs and other animals as introduced at the Board of Trustees meeting held on Friday, March 17, 2017 at 4:00 P.M. The law would pertain to the Village Beach, the public dock, the Village Green, the bay access walkway and the Post Fields pond area. Local Law No. 2 of 2017

A Local Law Amending Chapter 82 Of The Village Code With Respect To Dogs And Other Animals

Section 1. §82-2 is hereby amended by adding subsection G to read as follows:

G. It shall be unlawful for any person to feed any animal in or on any part of any recreation center or park of the Village of Quogue.

Section 2. This local law shall become effective upon the filing thereof with the Secretary of State of the State of New York.
