2019 INSTRUCTIONS FOR VILLAGE BEACH APPLICATION

Please allow at least five (5) business days for processing of your application.

Please complete the application with supporting documents and return it by mail, hand, facsimile or e-mail to the Quogue Village office at the appropriate address at the top of the application form.

The Village Office will be open on three Saturdays (May 18th, May 25th and June 1st from 9:00 A.M. until 1:00 P.M.) for PICKUP OF BEACH STICKERS. **NO APPLICATIONS WILL BE PROCESSED. ALL APPLICATIONS MUST BE SUBMITTED AT LEAST FIVE (5) BUSINESS DAYS PRIOR TO EACH OF THOSE SATURDAYS IN ORDER TO BE PICKED UP BY THEN.**

Beach stickers also may be picked up weekdays between 9:00 A.M. and 4:00 P.M.

2018 Stickers properly affixed to cars and 2018 passes will be valid through May 31, 2019.

Any form not completed properly or missing supporting documents cannot be held or processed and will be mailed back to you.

Village Beach Parking Permits will be issued upon completion of this application, **proof of registration (enclose photocopy)** of automobile in applicant's name (except as noted below) and payment of appropriate fee in the form of cash (**exact change only** if delivered by hand) or check payable to the Village of Quogue. If you would like to pay by credit card, please call our office at 631-653-4498 to process. Note: the credit card company's fee will be charged to your account.

If the registration is in a company name, please include paperwork showing the applicant's affiliation with that company. In the case of a property that is owned by a corporation, limited liability company, trust or entity, please provide proof of applicant's equity interest in such entity.

For rental cars, please include a copy of the rental agreement.

Please indicate if you would like the sticker and ID cards held for pick-up or mailed to you certified mail (an additional fee of \$5.00 is REQUIRED for certified mail – we cannot mail any other way).

Sticker must be adhered on the outside of the car window directly behind the driver. CARS WILL BE TOWED IF STICKER IS NOT AFFIXED PROPERLY. NO SCOTCH TAPE! PER SECTION 118-18 OF THE VILLAGE CODE. **** If for any reason you need to replace a sticker that has already been issued, you must peel off and return the original sticker to us.**

Two (2) I.D. cards are issued with each Village Beach Parking Permit for admittance without a car (bicyclers or walkers). If you need additional I.D. cards, they can be purchased for \$15.00 each. This I.D. card must be shown to the gatekeeper at each visit to the beach. **One card will admit up to four people.**

THE VILLAGE OF QUOGUE WILL NOT BE HELD RESPONSIBLE FOR PERMITS LOST IN THE MAIL. THERE WILL BE NO REPLACEMENT OF LOST, STOLEN OR MISSING PERMITS WITHOUT PAYMENT OF FULL FEE.

Parking Permits are limited to two (2) permits per household and include two (2) I.D. cards per permit.

The Quogue Village Beach lifeguards will be on duty 10:00 A.M. until 6:00 P.M. weekends only, including Memorial Day, starting on Saturday, May 25th through Sunday, June 30th, all week beginning on Monday, July 1st until Monday, September 2nd and weekends only, September 7th & 8th and September 14th & 15th
