

QUOGUE VILLAGE BEACH

2021 Opening and Safety Plan

The following rules will be followed and enforced until further notice:

1. On nights before the Village Beach will be open and staffed, the parking lot on the south side of Dune Road will be closed from 10:00 pm until 10:00 am the following morning. The north lot may be closed at 9:00 am in the discretion of the lifeguards in order to provide for setup of the beach.
2. Parking capacity will not be limited.
3. The locker rooms and the bathrooms will be opened every day commencing on Saturday May 29 but will only be attended when the beach is staffed.
4. Fully-vaccinated people need not wear face masks but may elect to do so. All others subject to the mask mandate under New York law shall be required to wear a mask whenever they are walking about the premises (other than while swimming or walking directly to or from the ocean) or when not maintaining at least a 6 foot distance from persons other than members of their own household.
5. Seating on the beach will be limited to specified areas to help assure spacing. When persons all known to each other to be fully vaccinated are seated or standing together, social distancing need not be observed. In all other cases when a person is seated or standing with or near someone other than a member of the same household, social distancing (at least 6 feet of space) must be observed whenever possible.
6. Tables and chairs may be used for eating, but at least 6 feet of space must be maintained between chairs at different tables.
7. The Village reserves the right to amend or modify these rules at any time without notice.
8. After one warning, a second infraction of the rules will result in a seven-day suspension of beach privileges. A third infraction will result in revocation of beach privileges for the season. In addition, a willful failure to follow a direction of a lifeguard or other beach staff member, code enforcement officer or police officer or a willful misstatement to them may result in immediate revocation of beach privileges for the season.

9. Parents will bear responsibility for the behavior of their children under age 16.
10. Purchase of a beach sticker or use of the Village Beach will constitute a person's acceptance of the foregoing rules as they may be amended or modified from time to time.

Lifeguards will place flags each morning to signify seating areas with separation between each area to assure social distancing. Seating will be within 8 feet of a flag only.

Each day, all employees will affirm absence of Covid-19 symptoms (fever, persistent cough, loss of smell and taste, fatigue, aches and pains, diarrhea) and disclose recent exposure to anyone having them for evaluation. Employees with such exposure who are not fully vaccinated will be sent home.

Upon entry patrons will be asked to affirm the absence of Covid-19 symptoms and disclose recent exposure to anyone having them. Patrons with such exposure who are not fully vaccinated will be asked to leave.

All bathrooms will be unisex. Only one person (or a parent and child or children) will be permitted in the bathroom at a time. Waiting lines will be socially distanced by floor markings.

The water fountain will be disabled and marked as closed.

Social distancing signage will be liberally posted throughout the premises.

Hand sanitizer bottles will be placed at high traffic areas on the decks.

Staff will clean each bathroom in the morning following New York DOH guidelines.

High touch areas such as faucets will be wiped down by staff regularly during the day.
